Call handler of choice prior to shipping to reserve spots if you do not, birds will be put in rotation. Breeder covers shipping cost and must send in a USPS approved box. All birds will be vaccinated for PMV upon arrival. No handler may handle his or her own birds. Handler positions open to Boston Concourse & Southern New England Members only. Must have electronic clock for race. First 35 birds will be auctioned off after race. Remaining birds are property of the handlers.
